

**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. \_\_\_\_**

An ordinance levying taxes for all town purposes for Capital Township, Sangamon County Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Capital Township, Sangamon County, Illinois as follows

SECTION 1: That the sum of Two Million Fifty Thousand Dollars (\$2,050,000) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: Town Fund and General Assistance for the year 2017.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
